Visual Processing is essential to the development of the young children we work with. This requires accurate detection of images as well as the ability to perceive and use what is seen. This 3 hour evening workshop will examine visual processing, cover basic techniques for identifying visual processing problems in young children, provide practical strategies for optimizing visual processing, and explore therapeutic activities that build skills.
