The VB-MAPP: Assessment, Goal Development and Intervention For Young Children

Course Description:

The Verbal Behavior Milestones Assessment and Placement Program (VB-MAPP) by Mark Sundberg, PhD, BCBA-D, is an assessment tool, curriculum guide and skills-tracking system based on B. F. Skinner's behavioral analysis of language. The VB-MAPP provides criterion-referenced information regarding a learner's current skill set, and provides a curriculum guide that can serve as a basis for the selection of teaching objectives. There are five components: (1) Milestones assessment, (2) barriers assessment, (3) transition assessment, (4) task analysis and skills tracking assessments, and (5) placement and IEP goal assessment. There are approximately 900 skills presented, covering the 16 areas of the VB-MAPP. Participants will get to review all five components of the VB-MAPP, practice scoring the assessments, and develop long term and short term teaching objectives. They will be able to utilize all strategies learned in their sessions with their students.

Who Should Attend: Behavior Analysts, speech pathologists, special educators, social workers, developmental specialists and other professionals who evaluate and treat young children with Autistic Spectrum Disorder.

Administer the VB-MAPP.

Analyze the results of the VB-MAPP.

Use the results of the VB-MAPP to develop long-term and short-term teaching objectives. (LTOs and STO)

Anya received her Bachelors Degree in 1995 in Psychology from Queens College. She completed her Masters Degree in 1996 in Child Development at Tufts University. Anya worked in the field of Early Intervention and Autism for over 10 years supervising ABA programs across NYC and Long Island. Currently, Anya works with the adult autism community. She is the Clinical Director of Day Habilitation programs for Quality Services for the Autism Community (QSAC) overseeing 12 Day Habilitation programs for individuals with ASD. Anya is a Board Certified Behavior Analyst and an active member of the autism community. She presents at local and national conferences on topics related to autism intervention. Anya is a Media Watch Writer for the Association for Science in Autism Treatment (ASAT). She has presented research on staff training and published articles on humanistic and behavioral perspectives as well as teaching deception skills to students with autism spectrum disorders. Anya is an Associate Professor at Hofstra University and she continues to collaborate on research presented at local and national conferences, committees, and for ASAT.
