Beyond Discrete Trial Instruction: Evidence-based Approaches for Young Learners with Autism Presented by Mary McDonald, PhD, BCBA-D, LBA

<u>Course Description</u>: This seminar will focus on a variety of research-based teaching strategies that extend beyond discrete trial teaching that have been shown to be successful for young children with autism. Specific interventions will be reviewed such as: peer-mediated interventions, incidental teaching, schedule-following and joint activity schedules, script-fading, and technology-based instruction. Research articles will be highlighted for each intervention throughout the presentation. Teaching methods will be discussed as they apply across curriculum domain areas. <u>Instructional Methods</u>: PowerPoint, Lecture, Discussion, Handouts, Interactive activities and video examples.

About our Presenter: Dr. McDonald is a Professor in the Special Education Department at Hofstra University where she directs the Advanced Certificate Programs including the advanced certificates in ABA in Severe and Multiple Disabilities. She teaches courses related to autism spectrum disorders, applied behavior analysis and single subject research design. Dr. McDonald serves as the Associate Executive Director of Long Island Programs for Eden II/Genesis Programs. She has over 25 years' experience directing programs for students with autism from early intervention through adulthood. Dr. McDonald completed her PhD in Learning Theory at the CUNY Graduate Center and is a Board Certified Behavior Analyst - Doctoral Level and a licensed behavior analyst. Dr. McDonald serves on a number of advisory boards and presents at local, national and international conferences on the topic of autism. She serves as an editor for the Journal of Behavior Analysis in Practice, Special Education, Research, Policy and Practice and the Journal of the American Academy of Special Education Professionals. She has published both peer-reviewed and popular articles in areas such as: self-management, social reciprocity, PECS, scripts and semantic webs, creativity and including students with ASD.
